TOURNAMENT RULES

ALL CURRENT USBC GENERAL PLAYING RULES WILL BE IN EFFECT!

1. ENTRY – Entry is open to any woman that has a membership in the Southeast MN USBC.
2. FEES – Fees are \$18 per event/per person. An optional All-Events category is an additional \$5. All fees must be paid by check or money order payable to: **Southeast MN USBC**. There will be a \$30 NSF check fee. **No entry fees can be returned or refunded.** **Brackets** will be available for an additional \$5 at the time of bowling.
3. TEAM – Any four (4) bowlers may form a team. Entrants may bowl more than once provided no more than two (2) players on any one team cashes more than once on the team prize list. Bowlers entered in more than one team event will use their first Team-score bowled towards the All-Events prizes.
4. DOUBLES & SINGLES – Bowlers may enter doubles & singles only once and must bowl both events.
5. SUBSTITUTES – A substitute is any bowler not listed on the entry form. Any substitutions must be reported to the Tournament Manager **at least 30 minutes prior to the start of any shift.**
No changes in line-ups will be allowed. Subs will be placed in the absent bowlers position only. Emergencies will be at the discretion of Tournament Manager.
6. HANDICAP – Handicap shall be 90% of the difference from 220 scratch, with no limit. Bowlers will use their final 2007-2008 average of 21 games or more. If no average, bowlers will use their highest current average as of Jan.25, with 12 games or more. All others must bowl scratch. Note; 10-pin Rule (319a) will be in effect, At the time of bowling, if an entrant has a current average for 21 games or more that is 10 pins or more higher than the prior season's average, the entrant must use the current average.
7. PRIZES – Prizes shall be awarded to one in four (4) entrants and individual trophies will be awarded to the champions of the Team, Doubles, and Singles events. Optional Handicap All-Events, \$5 entry fee, with 100% payback to 1 in 10 entrants.
8. MISC. – Any team bowling alone on a pair must complete the frame on one lane before starting the next frame on the opposing lane. No card playing will be allowed during any event in this tournament. No spectators and/or children are allowed in the settee area during this competition.
