2. Nominee must have participated 10 or more years in merged SEMNUSBC Association and it's predecessor local association.
3. Nominee shall have won Recognition for his/her ability in bowling and must have at least one of the following in Sanctioned/Certified competition.
A. A Rochester/SEMNUSBC Association Local Champion in Team, Doubles, Singles, or All Events.
B. Other tournament titles or accomplishments.
C. Other exceptional bowling accomplishments.

[] MERITORIOUS SERVICE

Must have a minimum of 10 years of service and One of the following

- 1. Exceptional Accomplishments as an Officer or Board of Director of the Local Association.
2. League Secretary or Officers for Outstanding Service to the League or Association.
3. Individuals who have contributed to the sport of bowling

[] PIONEER CATEGORY

The Hall Of Fame Board may select ONE Female and ONE Male in the Pioneer Category each year. The Pioneer Category shall honor those Men and Women, living or deceased, who became active in bowling activities prior to twenty five (25) years ago and have distinguished service or outstanding bowling accomplishments.
