## **RULES**

Entry will be open to all boys and girls that are current members of the Southeast MN USBC association.

**Entries:** Teams are comprised of four (4) person teams, any boy/girl combination. To ensure your date and time, the tournament entry form(s) and fee(s) are due to the Tournament Director on or before **January 12, 2009**. Entries taken after this date will be on a first come/first serve basis.

**Prizes:** All dollar amounts are issued as scholarships—not cash. 100% of the Plaque/scholarship fee will be returned. Guaranteed minimum prizes of, \$400 scholarships (\$100 per bowler), and plaques for first place teams, and \$200 scholarships (\$50 per bowler), and plaques for second place teams in each division. Scholarships will be awarded to the top 2 places in each division. Plaques will be awarded on a 1 in 10 ratio per division. The USBC **SMART** Program, (**S**cholarship **M**anagement and **A**ccounting **R**eports for **T**enpins) account #8614, will manage all scholarship money. Plaques will be issued based on the spelling of the names on the entry form so ***please print clearly and verify.***

**Averages:** Averages that will be used are; the highest 2007-2008 average (min 12 games). \*If a bowler does not have a 07-08 average, that bowler may use their highest current average as of Jan 12, 2009 (min 12 games). All bowlers without either average must bowl scratch. Failure to report correct average will result in disqualification and forfeiture of entry fee. USBC Rule 319a states, “When the previous season’s average is used, and at the time of bowling an entrant has a current average for 21 games or more that is 10 pins or more higher than the prior season’s average, the current average must be used.”, thus, a copy of the current average sheet must accompany all entry forms using current averages.

**Divisions:** All Divisions are determined by averages (total combined averages).  
Division 1; 501 and above,  
Division 2; 500 and below.

This is a handicap Tournament. A team handicap of 880 scratch will be used with 90% no limit handicap.

**Cost:** Cost is \$12 per person, or \$48 total per team. (\$28 for bowling fee, \$17 for Plaques/scholarships, \$3 expenses). Please include check(s) or money order(s), payable to **SOUTHEAST MN USBC** for \$48 with this entry form.

**Other:** If a bowler misses his/her shift; he/she is out the entry fee. A bowler that arrives late must take a zero score for all frames missed. Any unsportsmanlike conduct may result in disqualification from participation with no refund.

***Please check in 30 minutes prior to your scheduled shift time.***
