Participation in the tournament is open to all Women members of the SEMN USBC Association. All current USBC general playing rules will be adhered to.

**Entry fee is non-refundable.** All entries must be completed and turned in before the first shift on the first day of the tournament. Any other entries will be on a first come first serve basis depending on availability and at the discretion of the Tournament Director.

A Bowler may enter the Team event one time for every league they participate in as a regular bowler, taking into consideration the following conditions.

1. Not more than two players on the same team can place more than once in the Team event prize list.
2. Any bowler bowling more than one Team event will use their first Team event score to count towards their All-events score.

Bowlers may compete only once in singles and doubles. Bowlers entered in either event must bowl both events.

#### IMPORTANT

No changes in bowling lineup will be allowed.  
Substitutes will be placed in the absent bowlers position and must be made at least

Tournament is Handicapped based on a score of 220 scratch, 90% handicap with no limit.

All bowlers must use their highest final 2010-2011 average. If no final 10-11 average, bowlers must use their highest current SE MN USBC league average based on 21 games or more as of FEB. 6, 2012. All others must bowl scratch.

**NOTE: 10-PIN RULE (319a) WILL BE IN EFFECT**  
If, at the time of bowling, an entrant has an average for 21 games or more that is 10 or more pins higher than the prior season's average, the current average must be used.

It is the bowlers' responsibility to verify the accuracy of their average. Any failure, to submit the proper average or to report a need for correction of average prior to the time of bowling, shall be subject to disqualification of score. Corrections of averages can be made up to the completion of the first game.

The Doubles event will be bowled first, alternating lanes on pair that is assigned.

All Teams will bowl all three games alternating lanes on pair that is assigned. No exception, save for mechanical failure.

Any tournament game or frame(s) irretrievably lost due to malfunction of automatic scorer may be re-bowled upon the approval of the Tournament Director.

Violation of any USBC or Tournament rules will result in forfeiture of entry fees and prize winnings.

Lane dressing will be applied before each SHIFT.
